### **Strategies and Countermeasures**

### Distracted Driving Reduction Strategies - Revised

Strategy: Reduce fatalities and injuries by identifying and implementing strategies to reduce distracted driving.

### Countermeasures and Programs

- Develop a suite of countermeasures targeting distracted road users by age group.
- Test and implement TTI App to discourage DD among teens
- Inform the public about vehicle technologies designed to improve safety and encourage consideration of safety option when purchasing a new or used vehicle (Information available on the National Safety Council's website --Mycardoeswhat.org)
- Partner with the media to educate the public about the dangers of distracted driving.
- Conduct community events, employer programs, and other outreach activities on the dangers of distracted driving
- Provide education on distracted driving for law enforcement (dangerous behaviors targeting adults and citation options)

#### Strategy: Improve enforcement capabilities for addressing distracted driving.

• Encourage the use of phone records to identify and document distracted driving as a contributing crash factor

- Utilize Selective Traffic Enforcement Program (STEP) grants to enforce distracted driving state laws and local ordinances
- Utilize crash data to determine the deployment of STEP grants
- Catalogue potential citations for use as a surrogate to cite distracted drivers where appropriate state laws and local ordinances do not exist or the specific circumstances don't support their use
- Educate law enforcement on methods (potential citations) for preventing distracted driving by encouraging preventive enforcement
- Improve the effectiveness of distracted road user educational techniques, tools, and strategies.

## Strategy: Improve the effectiveness of distracted road user educational techniques, tools, and strategies

- Test the efficacy of current messaging with different age groups to determine which types are effective.
- Utilize crash data to determine the location of media buys and other education and awareness campaign methods

# Strategy: Improve distracted driving reporting as a contributing factor on crash reports.

• Catalogue and disseminate state laws and local ordinances

### Strategy: Increase the installation of engineering countermeasures known to reduce distracted driving

- Systemically increase the installation of rumble strips, wider, brighter striping, and lighting beginning in areas associated with distracted driving crashes
- Document the research and educate design engineers on the effectiveness of the Safety Edge
